The National Tunis Sheep registry, Inc. (NTSRI) invites you to consign sheep to the **Stars of Louisville All Breeds Bred Ewe Sale**. This sale is for EWES ONLY up to 5 years old of all sheep breeds.

This letter contains rules and conditions that the sale will be held under. Please read this carefully. When you submit entries to this sale, you are agreeing to abide by all rules and regulations of the sale. **DATE & LOCATION:** 2:00 PM on Saturday, November 14, 2020, Kentucky Exposition Center, Louisville, KY

**SHOW ORDER & SALE ORDER:** This will be determined by Sale Management based on numbers and breeds of ewes entered.

**JUDGE:** To be announced at a later date.

**AUCTIONEER:** Bill MacCauley, Pennsylvania.

ENTRY DEADLINE: All entries must be postmarked by OCTOBER 5 - Please be on

time!

**ENTRY FEES:** \$30.00 per head payable at time of entry.

**ENTRY INFORMATION:** Please use the enclosed entry form. If you are entering more than one breed, please use a separate form for each breed. Feel free to make photocopies of the blank form if you need extra forms. NTSRI reserves the right to edit or reduce the size of extremely long narratives. Use this space wisely. Substitutions will be allowed in or out of class. Information Sale Day will be accepted. However, it is strongly recommended that pedigree information be included on all entries. Entry fees will not be refunded on any sheep that fail to be in the sale. NOTE: If NAILE is canceled due to the coronavirus, NTSRI will return all entry fees.

**LATE ENTRIES:** Entries must be postmarked October 5 or before. NTSRI will accept late entries. Entries postmarked October 5 or before will be in the catalog. All entries postmarked after October 5 will be considered Late Entries and will be assessed a \$20.00 per head late fee. A consignor who has entries in the catalog and adds on additional entries will not be assessed this late fee.

**COMMISSION:** Sale charges will be 10% of your gross.

**SETTLEMENT CHECKS:** Settlement checks are normally mailed to consignors 30 days from the sale date for all sheep that are paid for at that time. No commission will be charged on sheep not yet paid for. Therefore, we do not get paid until you get paid.

**CLASSES:** In all breeds, classes may be split depending on the number of head entered and checked in. All ewes that are yearlings and older must sell as exposed or bred. Service sire information and Breeding Certificates must accompany registration papers at check in. If an overwhelmingly large number of sheep are entered, sheep may be grouped by age and be random drawn for sale order. These classes will be for **ALL BREEDS**:

Bred Ewes - Ages 2 thru 5 years Bred Yearling Ewes Ewe Lambs - Open

**EWE LAMB RULE:** Every consignor may enter one ewe lamb. To enter two ewe lambs, the consignor must also enter two bred ewes. After that, for each additional ewe lamb entered, the consignor must also enter one additional bred ewe.

**CATALOG:** Prior to the sale, a sale catalog will be posted on the Tunis website (<a href="www.countrylovin.com/NTSRI">www.countrylovin.com/NTSRI</a>) and on the websites of other participating sheep breed associations. A sale catalog will be printed and distributed to prospective buyers.

**REGISTRATION PAPERS:** All animals must have a valid registration paper. We WILL NOT accept applications for registry. **All registration papers must be turned in at sale check in.** Registration papers will be transferred and forwarded to the buyers. Cost of transfers will be deducted from consignors' settlements.

**HEALTH PAPERS:** Consignors must have a currently valid Certificate of Veterinary Inspection (CVI) for each sale animal issued within 30 days of the sale. A copy of the original CVI is acceptable for multiple entries. Two copies of the CVI must be provided for each entry (3 sheep = 6 copies). Health papers must include a Kentucky Permit Number. To obtain a Permit Number, have your veterinarian contact the Kentucky State Veterinarian's Office at 502/782-5901. Consignors who do not get a permit number will be responsible for the costs of obtaining it at the sale. **Each sale sheep must have a federal scrapie ID.** The following information must be legibly written or typed on all health papers:

- (1) Owner or Consignor name and address.
- (2) Species and purpose of movement.
- (3) Kentucky permit number.
- (4) Private flock tag number.
- (5) Federal scrapie ID number. (Must include premise ID and individual tag number.)

NOTE: Both private flock number and scrapie tag number must be listed.

- (6) Age, sex, and breed of each animal.
- (7) The following statement must be recorded on the CVI by the issuing veterinarian: "Sheep in this shipment are not known to be under any movement restrictions due to scrapie."
- (8) Signature and printed name, address, and phone number of accredited veterinarian.

**DNA DISCLOSURE:** All Consignors MUST declare DNA information for all breeds. This information will be printed on the sale order. Codon 171 (scrapie susceptibility) and Spider Syndrome genotype information must be disclosed at check in on any ewes selling in the following breeds: Hampshire, Oxford, Shropshire, Southdown, and Suffolk. Ewes selling in all other breeds must disclose Codon 171 information. NTSRI shall not assume any liability, legal or otherwise, expressed or implied, as it relates to this information. **Shropshires:** The Shropshire Association requires that all Shropshires must be NN and RR or QR. There will be no QQ or NS Shropshires allowed in the sale.

**FLOOR BIDS AND NO SALES:** There will be a minimum bid of \$300.00 for all sheep in this sale. Any ewe failing to bring the minimum will be "No Sale" and will be passed through the sale ring with no additional percentages charged. Consignors wishing to place a higher hold bid on their ewes, please talk to NTSRI people prior to the sale. All ewes with hold bids that are taken out of the ring as "No Sale" will have the full percentage of commission and fees charged against them based on the "No Sale" price. All animals checked in must pass through the sale ring.

**SETTLEMENT PAYMENTS:** Satisfactory settlement (payment in full) must be made with the clerks prior to the movement of any purchases from the sale facility.

**MANAGEMENT SERVICES & STATEMENT:** NTSRI assumes all costs normally related to the sale, including the room rent, judge fees, veterinary fees incurred for the purpose of reissuing health papers to new buyers, and a complete catalog, as well as other incidental costs normally associated with a sheep sale. NTSRI will use its best effort to secure payment for each animal sold, but does not guarantee the collectability of buyer. NTSRI does not guarantee against theft, illness, or loss of animals consigned and/or sold.

**CONSIGNORS:** Consignors are responsible for the costs incurred in the preparation and transportation of your sheep, feed, and bedding at the sale. The selling of sheep in this sale constitutes a contract between the buyer and seller.

**TERMS & SALE GUARANTEE:** The choice of law for this contract is Kentucky. Entry of sheep in this sale implies that the consignor agrees to conditions as set forth for this sale. All consignors agree that all sheep are guaranteed breeders. All lambs sold must maintain their lamb teeth 12 months from the date of their birth as recorded on their registration papers. Any warranty regarding health and viability of sale sheep, whether expressed or implied, will be strictly between the buyer and consignor and not NTSRI. Neither NTSRI, the sellers, nor any other person connected with the sale, assumes any liability – legal or otherwise.
