- 1. Call to order: The meeting was called to order at 7:35pm by President Anne McIntyre-Lahner.
- 2. - 3. Secretary Report: PayPal is once again live to pay memberships. Oregon Secretary of State has been renewed. We do not need to file with the Oregon Department of Justice. I am working at going through all the prior PayPal account for memberships. I also went through AR spreadsheet and am trying to reconcile them. Patricia moved to accept the Secretary report. No money has been given to ARBA and NARA will be in charge of dispersing funds. This is a one time scholarship given by NARA. Stephanie clarified the location of the National Meeting. 8. Old Business:
